XIV. PROGRAM DEVELOPMENT

Clinical Scientist Training Program (CSTP), University of Pittsburgh School of Medicine. In 2003, I developed this 5-year dual MD/MS or Certificate in Clinical Research in collaboration with Dr. Wishwa N. Kapoor, Director of the Institute for Clinical Research Education, The CSTP (MD/MS), a sister program to the Medical Scientist Training Program (MSTP, MD-PhD), was supported by institutional funding from the Dr. Arthur Levine. Vice Chancellor of the Schools of the Health Sciences and Dean of the School of Medicine. The aim of the program was to increase the pipeline of clinical scientists. CSTP students received merit-based scholarships and completed longitudinal career development activities. 15 months of full-time mentored clinical research, and graduate coursework towards a Certificate or Master of Science in clinical research over five years. During my tenure leading the CSTP between 2003-2015, I was responsible for recruitment and selection of candidates; annual evaluation and promotion; academic advising; mentor-matching; teaching the longitudinal seminar; and chairing each student's MS thesis committee (see full list in Section X.C). Annually we recruited between 2-8 students: at steady state, there were typically 25 students across 5 program years. Program outcomes included productivity in the form of manuscripts, self-assessed performance on the clinical research appraisal inventory, and retention into academic career. Approximately 60% of CSTP graduates who have completed their terminal training are engaged in academic careers.

Susan & Richard Levy Health Care Delivery Incubator (Incubator). In 2019. I started the Susan & Richard Levy Health Care Delivery Incubator (Incubator) in collaboration with Mary Oseid at Dartmouth-Hitchcock Health (D-HH). The Incubator is a joint venture between The Dartmouth Institute for Health Policy and Clinical Practice (TDI) and D-HH supported by philanthropic and institutional funds from both the Geisel School of Medicine and D-HH, including a gift from Dick and Susan Levy, the Susan J. and Richard M. Levy 1960 Distinguished Professorship, the Susan J. and Richard M. Levy 1960 Research and Program Support fund (Presidential Matching Fund), and the Health Transformation Research Fund at D-HH. The aim of the program is to support transformational health care redesign to improve serious illness care experiences for patients, family members, and providers; to ensure alignment between patient's goals and the medical care that they receive; and to reduce spending on unnecessary, ineffective, or unwanted interventions that may contribute to financial toxicity. Between 2019-2022 the Incubator funded ten project teams to develop and test health care delivery interventions within the D-HH system. Outcome metrics include team satisfaction, productivity, student and faculty engagement, and clinical redesign outcomes including patient and family satisfaction, patient-reported outcome measures, length of stay and readmission, total health care use, and return-on-investment. The average time to return on investment in each team's one-year team financial support is 1.8 years.
